
Letter of Approval for Yunnan Baishui River Hydropower Station Project As a Clean Development Mechanism Project by National Development and Reform Commission of the People's Republic of China

No. 137

The Chinese Government approves the Yunnan Baishui River Hydropower Station Project as a Clean Development Mechanism project, with the following remarks:

1. China approved the Kyoto Protocol to the United Nations Framework Convention on Climate Change on 30 August 2002, and is a Party to the Kyoto Protocol.
2. The Yunnan Baishui River Hydropower Station Project complies with the permission requirements provided for in the Measures for Operation and Management of Clean Development Mechanism Project in China, and assists China in achieving sustainable development.
3. Yunnan Zhongdayanjin Power Generation Co., Ltd is hereby authorized as China's participant to voluntarily participate in and carry out the project activity.
4. Yunnan Zhongdayanjin Power Generation Co., Ltd is permitted to transfer to International Bank for Reconstruction and Development as Trustee of the Italian Carbon Fund no more than 2,200,000 tCO₂e in total Certified Emission Reductions (CERs).
