To know the additional income deriving from these reductions post-marketing, perform the following calculation:

Additional income = (GHG reduction) x (price of carbon credit) x (Exchange rate of dollars in FCFA)

Example: Assuming that:

Reduction of GHG / year = 96,000teqCO2

1 carbon credit = 1 teqCO2

1 carbon credit = \$ 5 (minimum case)

1 USD = 450 FCFA

96,000 * 5 * 450 = **216,000,000 CFA francs** a year as a

minimum annual additional income

WHAT IS CDM?

CDM means Clean Development Mechnism.

It derives from the United Nations Framework Convention on Climate Change and the Kyoto Protocol.

It is a tool in the fight against climate change.

HOW TO PROCEED WITH CDM?

- Implement CDM means to implement projects that reduce Greenhouse gas emissions (GHG) while contributing to sustainable development of the country.
- Implement projects that reduce GHG emissions means that we must identify sources of greenhouse gas emissions and thus eliminate or reduce these emissions at the source.

WHAT ARE THE ELIGIBILITY CONDITIONS FOR A PROJECT TO BE CDM?

To be eligible for CDM, a project must:

- Meet the criteria of sustainable development of Côte d'Ivoire;
- Reduce greenhouse-gas emissions;
- be in one of the following sectors defined as: waste, forestry, agriculture, improvement, energy efficiency, substitution, fuels and renewable energy are.

WHAT ARE THE CDM BENEFITS?

All projects that meet this definition will therefore benefit from additional income that increases with the amount of greenhouse gas emissions avoided by the project. Implement a CDM project could also have the following benefits:

- access to climate-friendly technologies;
- improved infrastructure and job creation;
- · better air quality, so health
- · energy efficiency;
- lower energy costs;
- · reduced dependence on fossil fuels;
- income from the sale of credits for reducing carbon emissions.

WHAT IS THE ENTITY IN CHARGE OF CDM AT THE NATIONAL LEVEL?

Created by decree No. 232 of December 5, 2005, the CDM National Authority of Côte d'Ivoire (AN-MDP) is responsible for guiding and monitoring of the clean development Mechanism. AN-MDP works under the Ministry of the Environment.

AN-MDP in its chart has the advantage to integrate both the private and public sector, and also the civil society.

The CDM National Authority is housed within the National Agency for Environment (ANDE).

WHAT ARE THE MISSIONS OF THE CDM NATIONAL AUTHORITY?

- apply the government's policy for CDM;
- Represent the State vis-à-vis any entities connected with the CDM;
- Organize and coordinate the activities and guide stakeholders involved in the CDM;
- facilitate and promote capacity building, marketing services and national expertise in CDM;
- Evaluate and approve CDM projects
