THE CDM

CDM means <u>Clean Development Mechnism.</u> It derives from the United Nations Framework Convention on Climate Change and the Kyoto Protocol.

It is a tool in the fight against climate change.

HOW TO PROCEED WITH CDM?

Implement CDM means to implement projects that reduce Greenhouse gas emissions (GHG) while contributing to sustainable development of the country.

WHAT ARE THE ELIGIBILITY CONDITIONS FOR A PROJECT TO BE CDM?

To be eligible for CDM, a project must:

 Meet the criteria of sustainable development

of Côte d'Ivoire;

- Reduce greenhouse-gas emissions;
- be in one of the following sectors defined as:

waste, forestry, agriculture, improvement, energy efficiency, substitution, fuels and renewable energy are.

THE PoA

- PoA means Programme of Activities, it is defined as a modality of implementation of CDM projects and includes several CDM projects.
- The PoA is implemented in the same sectors of activities as the standard CDM .
- Each CDM Programme of Activities is called CPA ie Component Program of Activity.
- The lifetime of a PoA is 28 years.
- PoAs are primarily designed for small CDM projects developers that do not necessarily have a lot of means to carry out from the beginning big projects. Indeed, with the PoA, each programme component can be included progressively over the lifetime of the PoA.
- In this context, can be included in the same programme, projects with the same type or using the same calculation methodology.
- Of course these programme of activities can be applied to more ambitious plans, when they met eligibility and monitoring criteria applied.

ADVANTAGES OF POA

- Full expandability of PoA as opposed to a standard CDM, a PoA should not define exante the scale and location of each programme component (CPA).
- Single registration for the whole programme and not for individual CPAs so reduction of transaction costs related to national approval, validation, registration and verification of CPAs included later because of simplification of the process.
- Well done, PoAs also allow project owners to benefit from carbon finance in the early stages of projects and they can incorporate it into their financial plan.

.

- A remarkably reduced time to market for CDM project developers who want to ensure carbon revenues.
- Carbon revenues made bankable due to the reduction of risks of non-registration and also the time needed to carry out CDM revenue.
