II. ANNOTATIONS TO THE PROPOSED AGENDA

1. Membership issues (including disclosure of possible conflict of interest)

- 1. The Chair shall ascertain whether (a) the members present constitute a quorum, and (b) the absence of any member or alternate member is "without proper justification".
- 2. Action: The Board may wish to <u>consider</u> information provided by any member and alternate member, including with respect to any potential conflict of interest, and take action, as appropriate.

Background: The Chair shall <u>request</u>, at the beginning of each meeting of the CDM Executive Board, members and alternates to disclose whether they consider to have any conflict of interest relating to the work of the Board.

2. Adoption of the agenda

3. Action: Members may wish to adopt the proposed agenda for the thirty-sixth meeting.

Background: The Board agreed, at its thirty-fifth meeting, on items to be included in the provisional agenda for its thirty-sixth meeting. In accordance with rule 21 of the rules of procedure of the Board, subsequent additions or changes to the provisional agenda by members and/or alternate members were to be incorporated in the proposed agenda. The proposed agenda was transmitted to the Board on 5 November 2007 and thereafter posted on the UNFCCC CDM website.

3. Work plan

(a) Accreditation of operational entities

4. **Action**: The Board may wish to <u>take note</u> of the twentieth progress report on the work of the CDM Accreditation Panel (CDM-AP) which will be submitted on Tuesday, 13 October 2007, and an oral report by its Chair, Mr. Hernán Carlino, on the work of the CDM-AP.

Background: The CDM-AP held its thirty-second meeting on 7 - 9 November 2007.

Case specific

5. Action: The Board may wish to <u>consider</u> the recommendation from the CDM-AP on a spot-check case, decided by the Board at its twenty-fourth meeting.

Background: At its twenty-fourth meeting, the Board, agreed to undertake a spot-check of the DOE. The Board, at its thirty-second considered the recommendation of the CDM-AP on the implementation of corrective actions by one DOE under spot-check. The Board took note that the DOE has undertaken a significant work in response to the non-conformities and agreed not to suspend the accreditation status of the DOE. The Board also agreed with the recommendation of the CDM-AP that the DOE shall undertake work on three project activities under the observation of the CDM-AP. The Board also noted that it will follow this case carefully and requested the DOE to ensure that it continues to meet the quality standards and expectations of the Board in carrying out its validation and verification work.

6. Action: The Board may wish to <u>consider</u> the recommendation from the CDM-AP on a spot-check case.

Background: At its thirty-fourth meeting, the Board, taking into consideration an institutional issue related to a DOE, agreed to undertake a spot-check of the DOE. The Board also agreed on the scope of the spot-check and requested the CDM-AP to undertake this spot-check in an expeditious manner.

7. **Action**: The Board may wish to <u>accredit and to provisionally designate</u> entities for sector specific validation and/or verification/certification functions.

Background: In accordance with the accreditation procedure, the recommendations for phased accreditation and the supporting documentation are confidential and have been sent under separate cover on Tuesday, 13 November 2007.

General guidance

8. Action: The Board may wish to <u>consider</u> the initial assessment prepared by the secretariat on issues resulting in requests for review and reviews.

Background: In the context of the preparation of the VVM, the Board at its last meeting requested the secretariat to compile and assess in a systematic manner, the issues resulting in requests for review and reviews undertaken so as to categorize them and disseminate this information. This information is intended to enable the Board to provide the DOEs and project participants with a systematic feedback to enable continuing improvement in their performance.

9. Action: The Board may wish to appoint one additional expert as member of the CDM-AP.

Background: At its thirty-fifth meeting the Board also agreed to open a call for experts to replace an outgoing member of the CDM-AP. The Board requested the secretariat to open the call with a view to prepare a shortlist of experts for consideration by the Board at its thirty-sixth meeting. The Board also noted that the new member, if possible, should not come from the same region as the members that are in office. The Board, however, encourages candidates from all regions to apply.

(b) Methodologies for baselines and monitoring

10. **Note**: Due to the proximity of the closing date of the thirtieth meeting of the Meth Panel to the date of publication of these annotations an addendum will be issued on 21 November 2007 containing the annotations relating to this agenda item.

(c) <u>Issues relating to CDM afforestation and reforestation project</u> activities

11. *Note*: Due to the proximity of the closing date of the seventeenth meeting of the Afforestation and Reforestation Working Group to the date of publication of these annotations an addendum will be issued on 14 November 2007 containing the annotations relating to this agenda item.

Background: The Board had approved procedures for registration of Programme of Activities (PoA) for CDM A/R project activities at its thirty-second meeting. The CDM PoA and CPA Design Document forms for A/R and small-scale A/R PoA have been prepared with a view to facilitate the implementation of A/R PoAs in accordance with the guidance on registration of project activities under a PoA as approved by the Board at its thirty-second meeting. At its thirty-fifth meeting, the Board considered a proposal by the secretariat on draft forms for the programme of activities (PoA) for afforestation and reforestation project activities, and requested the secretariat to further revise the forms taking into account the guidance on PoA, for consideration at its next meeting.

(f) Matters relating to the registration of CDM project activities

14. ► *Action*: The Board may wish to <u>take stock</u> on the progress of registration.

Background: The information available in the section on "Project Activities" on the UNFCCC CDM website (http://cdm.unfccc.int/Projects), indicates the status of project activities submitted for registration. The main information, as of 12 November 2007, can be summarized as follows:

- (a) Registered CDM project activities: 844 (eight hundred and forty-four);
- (b) Request for registration: 50 (fifty);
- (c) Request for review: 48 (forty-eight);
- (d) Corrections requested: 38 (thirty-eight);
- (e) Under review: 8 (eight);
- (f) Rejected CDM project activities: 46 (forty-six);
- (g) Withdrawn: 8 (eight).

- (b) Requests for Issuance: 6 requests, 1,792,127 aggregate CERs
- (c) Requests for review: 12 requests, 1,855,824 aggregate CERs
- (d) Under review: 4 requests

Background: Three (3) or more members of the Executive Board or one Party involved requested a review of the requests for issuance listed in table 4 above. In accordance with the "Procedures for review referred to in paragraph 65 of the modalities and procedures for a clean development mechanism", for each case the Board shall decide whether to instruct the CDM registry administrator to issue the requested CERs (case A in table 4), to issue CERs following corrections (case B in table 4) or to undertake a review of the request for issuance (case C in table 4). Background: At its thirty-fifth meeting the Board decided to place the project activities identified in table 5 above under review. A review has been conducted by the review teams and a recommendation has been circulated to the Board. In accordance with the "Procedures for review referred to in paragraph 65 of the modalities and procedures for a clean development mechanism", for each case the Board shall decide whether to approve the proposed issuance of CERs (case A in table 5), to request the DOE to make corrections based on the findings from the review before approving the isuance of CERs (case B in Table 5), or to decline to approve the proposed issuance of CERs (case C in Table 5).

Background: At previous meetings, following consideration by the Board of the reviews of requests for issuance of the project activities listed in table 6 above, the Board agreed that CERs could be issued following corrections. The DOEs have submitted revised documentation which the Board may wish to consider in accordance with the clarifications to paragraph 18(b) of the "Procedures for review referred to in paragraph 65 of the modalities and procedures for a clean development mechanism". If the Board considers the corrections as satisfactory, the CERs shall be issued (case A in table 6), otherwise the request shall be rejected (case B in table 6).

24. *Action:* The Board may wish to <u>provide guidance</u> in relation to requests for deviation submitted by DOEs prior to issuance.

Background: Seven (7) requests for deviation have been submitted by a DOE to the Board since its thirty-fifth meeting for consideration by the Board at its thirty-sixth meeting.

(h) <u>Modalities for collaboration with the Subsidiary Bodies</u>

25. **Action**: The Board may wish to take note of issues to be considered at the twenty-seventh session of the Subsidiary Bodies related to the clean development mechanism.

Background: SBSTA 27 under agenda item 9(a) shall discuss the issue of "Implications of the establishment of new hydrochlorofluorocarbon-22 (HCFC-22) facilities seeking to obtain certified emission reductions for the destruction of hydrofluorocarbon-23 (HFC-23)" to provide its conclusions to CMP 13, if possible. As per discussions at SBSTA 26 two Parties made submissions on practical approaches to address the implications of crediting new HCFC-22 production facilities under CDM, as contained in FCCC/SBSTA/2007/MISC.17.

SBSTA 27 under agenda item 9(b) shall discuss the implications of possible changes to the limit for small-scale afforestation and reforestation clean development mechanism project activities. The COP, by its decision 1/CMP.2, (para 27) requested Parties, inter-governmental organizations and non-governmental organizations to submit their views to the secretariat, by 23 February 2007, on the implications of possibly changing the limit for consideration at SBSTA 26. The SBSTA took note of the submissions from Parties regarding implications of changing the limit to small scale A/R project activities at its twenty sixth session. In concluding the SBSTA agreed to undertake further analytical assessment of the implications of possibly changing the limit, based, inter alia, on national experiences, to include social-, economic- and environmental effects including estimation of leakage and requested the Parties, intergovernmental and non governmental

organizations to submit their views for consideration at SBSTA 27 (paras 78, 79 of SBSTA 26 report: FCCC/SBSTA/2007/4). The submissions are available in FCCC/SBSTA/2007/MISC.19 and FCCC/SBSTA/2007/MISC.19/Add.1.

SBSTA 27 under agenda item 9(c) shall discuss carbon dioxide capture and storage in geological formations as clean development mechanism project activities. The CMP, by its decision 1/CMP.2, (paragraph 21) first requested intergovernmental organizations and non-governmental organizations and then Parties (paragraph 22) taking into consideration the above submissions, to provide information to the secretariat on several issues (paragraph 21) concerning the consideration of carbon dioxide capture and storage as clean development mechanism project activities. Submissions from Parties are contained in document FCCC/SBSTA/2007/MISC.18 and its addendum FCCC/SBSTA/2007/MISC.18/Add.1 and submission from accredited non-governmental organizations are available on the UNFCCC website http://unfccc.int/parties and observers/ngo/items/3689.php>.

SBI 27 under agenda item 13 shall consider the progress on the implementation of the ITL and the go live with the CDM Registry, national registries and CITL, as presented in the Report of the administrator of the international transaction log under the Kyoto Protocol. The submission is contained in document FCCC/KP/CMP/2007/5.

4. Management plan and resources for the work on the CDM

26. Action: The Board may wish to: (a) take note of the report by the secretariat on the status of resources; (b) take note of the presentation of the secretariat highlighting the main activities defined by the latest version of the CDM-MAP and their financial implications, with the view of adopting it (c) take further action, as necessary.

Background: The current status of income and expenditure is presented in annex 5 of these annotations.

5. Other matters

(a) Regional distribution of project activities²

27. **Action**: The Board may wish to <u>take note</u> of the current status of distribution of CDM project activities.

Background: The CMP at its second session adopted decision 1/CMP.2, which contains several elements relating to regional distribution and capacity building, including an encouragement to the Executive Board to continue to facilitate the regional distribution of project activities.

(b) Relations with Designated National Authorities

28. Action: The Board may wish to <u>note</u> the briefing of the secretariat on the preparations of the fourth meeting of the CDM DNA Forum to be held on 29 - 30 November 2007 in Bali, Indonesia.

Background: The CMP at its first session requested the Board, in relation to regional distribution and capacity-building, to broaden the participation in the CDM, including through meetings with a designated national authorities forum in a regular basis in conjunction with meetings of CMP and its subsidiary bodies. The Board, at its twenty-third meeting, agreed to establish the CDM DNA forum and requested the secretariat to provide support to this forum.

Board members and alternates continued receiving communications from the public and invitations to participate in CDM-related events.
