





Draft revision to the approved baseline and monitoring methodology AM0062

"Energy efficiency improvements of a power plant through retrofitting turbines"

I. SOURCE, DEFINITIONS AND APPLICABILITY

Sources

This baseline and monitoring methodology is based on the following proposed new methodology:

• NM0203-rev: "Energy efficiency improvements of a power plant through retrofitting turbines", which is based on the project activity "Energy efficiency improvements of Pucheng Power Plant through retrofitting turbines in China", proposed by China Huadian Corporation, China, whose baseline and monitoring methodology and project design document were prepared by Mitsubishi Research Institute Inc., Japan.

This methodology also refers to the latest approved versions of the following tools:

- Tool to calculate project or leakage CO₂ emissions from fossil fuel combustion;
- Combined tool to identify the baseline scenario and demonstrate additionality; and
- Tool to calculate emission factor for an electricity system;
- Tool to determine the baseline efficiency of thermal or electric energy generation systems.

Selected approach from paragraph 48 of the CDM modalities and procedures

"Existing actual or historical emissions, as applicable".

Definitions

For the purpose of this methodology, the following definitions apply:

Grid/project electricity system is defined by the spatial extent of the power plants that are physically connected through transmission and distribution lines to the project activity (e.g. the power plant location or the consumers where electricity is being saved) and that can be dispatched without significant transmission constraints, as defined in "Tool to calculate emission factor for an electricity system".

Project activity turbine (PAT). The turbine,¹ that is retrofitted under the project activity. There can be more than multiple turbines retrofitted, which can be eligible as CDM project activities under this methodology, subjected to criteria as mentioned in the third applicability condition.

¹ In case of multi-cylinder steam turbine including high pressure, medium pressure and low-pressure stage cylinders, the PAT covers the entire turbine system, which includes all the cylinders.





Applicability

The methodology is applicable to project activities where steam turbines and gas turbines are retrofitted with component(s) of improved design for energy efficiency improvements in an existing fossil fuel power plant.

The methodology is only applicable if all the following conditions are met:

- (1) The electricity is generated using fossil fuels;² no biomass or waste heat is used;
- (2) The power plant where the project activity is applied supplies electricity to a grid only;
- (3) In case of steam turbines, the steam supply and electricity generation should be separately measureable for each turbine retrofitted under the project activity;
- (4) Activities covered under the following two categories are not eligible as CDM activity under this methodology:
 - (a) All the recommended regular or preventive maintenance activities (including replacements and overhauling) as provided by the manufacturer of turbine;³
 - (b) A superior practice of preventive maintenance e.g. sophisticated cleaning systems, resulting into an improved efficiency compared to historical efficiency after maintenance;
- (5) Project activities are only eligible when:
 - (a) The operational parameters of turbines, that affect the energy efficiency of turbine, remain the same (subject to a variation of $\pm/-5\%$) in the baseline and the project scenario (e.g. steam pressure and temperature, quality of steam in the case of a saturated steam turbine; condenser vacuum, and combustion temperature for gas turbine);⁴
 - (b) The project activity does not increase the lifetime of the existing turbine during the crediting period (i.e. this methodology is applicable up to the end of the lifetime of the existing turbine, if shorter than crediting period);

- Cleaning of turbine rotor blades, removal of scales, cleaning of casing;
- Inside cleaning of oil tanks;
- Cleaning and replacement for turbine oil filter;
- Declination measurement of shaft, measurement for horizontal flange level;
- Bolt adjustment, gap measurement for bearings and valve shafts;
- Detailed check for major valves, check for speed governing device;
- Check for gear and bearings of turning devices;
- Decomposition of turbine lubrication oil device.

² This methodology is not applicable for turbines used in renewable energy power plants, as a different approach is required for the emission reduction calculations of these turbines as compared to the procedure provided in this methodology.

³ 'Regular maintenance' of turbines in this methodology mainly refers to preventive maintenance activities conducted intensively during a certain period. Regular maintenance activities include daily inspections and repair of the equipment. Examples of periodic (e.g. every four years) inspections of turbines included in 'regular maintenance' are listed below:

⁴ The validating/verifying DOE shall confirm that key operational parameters in project activity are in the same range as in the baseline.





(6) Where applicability conditions of the latest version of Board approved "Tool to calculate emission factor for an electricity system" apply.

The methodology is not applicable:

- To project activities that involve fuel switch;
- To combined cycle power plants, cogeneration plants, or the power plant that is part of an industry and a portion of the electricity is used to meet the internal demand of the industry.⁵

Finally, this methodology is only applicable if the application of the procedure to identify the baseline scenario provides the results that the continuation of the current practice is the most plausible baseline scenario.

II. BASELINE METHODOLOGY PROCEDURE

Project boundary

The spatial extent of the project boundary, in the power plant where the project activity is implemented, includes:

- For steam turbine(s), the turbine(s) that is/are retrofitted and directly connected to an electric generator (turbo-generator), boiler and condenser;
- For gas turbine(s), the turbine that is retrofitted and directly connected to an electric generator (turbo-generator), that consists of turbine, compressor, combustor and generator.

The project boundary also includes the electricity system to which the CDM project is connected as per the "Tool to calculate emission factor for an electricity system".

⁵ The applicability is restricted because the methodology does not have procedures to account emissions reductions for situations where the ratio of electricity supplied to industry by turbine to the total electricity generated by turbine of electricity generated by industry power plant changes between the baseline and the project activity. Though, if it can be clearly demonstrated that the electricity generated by industrial power generation turbine, where proposed project activity is implemented, is exported only to a grid then the methodology is applicable. In such cases it also needs to be demonstrated that the electricity system associated with such power generation turbine and its connection to grid is historically completely isolated from other turbines and electricity system, which supply part or full electricity to industrial processes. The isolation of the turbine is maintained over the crediting period.




Figure 1: Conceptual diagram of the project boundary for steam turbine and gas turbine

The conceptual diagram of the project boundary for the case of a steam turbine and gas turbine is shown separately in Figure 1.

Procedure for estimating lifetime of the turbine(s)

In order to estimate the remaining lifetime or the time when the existing turbine would need to be replaced in the absence of the project activity, project participants shall take the following approaches:

- (a) The typical average technical lifetime of the type of equipment shall be determined and documented in the CDM-PDD, taking into account common practices in the sector and country, e.g. based on industry surveys, statistics, technical literature, etc.;
- (b) The practices of the responsible company regarding replacement schedules shall be evaluated and documented in the CDM-PDD, e.g. based on historical replacement records for similar equipment.

Specially for gas turbines, the different lifetimes of the different parts of the turbine should be defferentiated, considering any scheduled part replacement program from the manufacturer.

The point in time when the existing equipment would need replacement in the absence of the project activity should be chosen in a conservative manner, i.e. the earliest point in time should be chosen in cases where only a time frame can be estimated or where some parts of the turbine have a shorter lifetime than the other parts, and should be documented in the CDM-PDD.

The emission reductions can be claimed for the minimum period between the crediting period and the lifetime of the turbine.





Procedure for the identification of the most plausible baseline scenario and the demonstration of additionality

The selection of the most plausible baseline scenario shall be performed in accordance with the latest approved version of the "Combined tool to identify the baseline scenario and to demonstrate additionality". The section below provides additional information to that provided in the tool for using the tool.

Step 1: Further guidance on identification of alternative scenarios

The tool requires identification of all other plausible and credible alternative scenarios to the project activity scenario, including the common practices in the power sector that deliver electricity with comparable quality, properties and application areas. Provide common practices of maintenance, repair and retrofit of turbines in the CDM-PDD, that have been implemented previously or are currently being applied in the relevant geographical areas (defined by the grid as in the Tool to calculate emission factor for an electricity system) taking into account the characteristics (size, technology, age) of power plants by documentation taking into account maintenance and repair records, updated information by turbine manufacturers, literature, and policy direction.

All identified scenarios should be technically feasible alternatives to provide the amount of electricity generated by the project activity throughout the crediting period. For example, if it is not possible to provide sufficient electricity with the continuation of the current practice or if the current practice is too unreliable to be continued, it cannot be considered a credible alternative scenario.

The alternative baseline scenarios, which should be considered, include inter alia:

- Continuation of the current practice the turbine continues to be operated without retrofitting;
- Turbine retrofit project activity is implemented without CDM;
- Part of turbine retrofit project activity is implemented without CDM;
- Turbine retrofit project activity (or part thereof) is implemented without CDM at a later point in time when technology is more common practice or other barriers are removed;
- A new turbine (either steam turbine, open cycle or combined cycle turbine) with a higher efficiency is installed to replace the existing turbine;
- Other retrofit activities that could result in increase in electricity generation.

Step2: Investment analysis

When making an investment analysis, the increase in power generation of the retrofitted system compared to the baseline system has to be taken into account when calculating cash flows.

Step 3: Further guidance on common practice analysis

Analyze power plants with the similar characteristics with respect to size (within 50% of nameplate capacity), technology (steam turbine or gas turbine), age (within similar plant is max. 10 years older or younger) to cover electricity supplied in the relevant geographical area as defined by the grid. If the






relevant geographical area does not include at least five similar power plants, it has to be expanded to the whole host country. Other registered CDM project activities are not to be included in this analysis. Provide documented evidence and quantitative information in the CDM-PDD.

The methodology is only applicable, if the baseline selection demonstrates that the baseline scenario is the following:

Electricity would be generated by the operation of the power plant without retrofitting the turbine, by gridconnected power plants.

Baseline emissions

Electricity generation in the project activity power plant will displace in the baseline scenario less efficient electricity generation in the project plant and can, in addition, displace electricity in the grid, if the quantity of electricity generation is increased as result of the project activity. The calculation of baseline emissions is therefore based on different emission factors for different quantities of electricity generated. As represented in Figure 2, the following cases are differentiated:

The baseline emissions for year 'y' (BE_v) are calculated as follows:

Step 1: Determine Baseline Emissions for different scenarios of project electricity generation

Since the project activity turbine provides electricity to the grid, the following cases are differentiated:⁶

Case a) The quantity of electricity generated in the project activity turbine $(EG_{PJ,y})$ exceeds the maximum annual quantity of electricity that the turbine could have produced prior to the implementation of the project activity (EG_{MAX}) . Baseline emissions are calculated as:

Case b) The quantity of electricity generated in the project activity turbine $(EG_{PJ,y})$ exceeds the historic average annual generation level (EG_{AVR}) but is lower than the maximum annual quantity of electricity that the turbine could have produced prior to the implementation of the project activity (EG_{MAX}) . Baseline emissions are calculated as:

Case c) The quantity of electricity generated in the project activity turbine $(EG_{PJ,y})$ is lower or the same as the historic average annual generation level (EG_{AVR}) . Baseline emissions are calculated as:

⁶ If electricity generation in the project activity turbine is increased beyond historical levels after the implementation of the project activity, it is difficult to clearly attribute whether such an increase is the result of the CDM project activity or would have occurred anyhow. If the increase is a result of the project activity, the project activity displaces grid electricity; if it is not a result a of the project activity, the use of fossil fuel in the project activity turbine is displaced. To deal with this uncertainty in this methodology, the lower emission factor between the project activity turbine fired with the baseline fuel and the grid emission factor is used, as a conservative approach.

Note for above equations: When the project efficiency of turbine $\eta_{PJ,y}$ is above maximum efficiency of turbine $\eta_{PJ,max}$ (as defined in section III), the adjusted generation-supply of electricity ($EG_{PJ,y,adjusted}$) needs to be used in place of electricity supply generation ($EG_{PJ,y}$). For the procedure to estimate $EG_{PJ,y,adjusted}$ please refer Step-3 in this section.

Calculation of EG_{MAX}

The maximum annual amount of electricity that could have been supplied to the electricity grid by the PAT prior to the implementation of the project activity is calculated as:

⁷ The efficiency of turbine in the project and the baseline implicitly takes into account the efficiency of electricity generation and not break horsepower.


⁸ Re-heaters between turbines cylinders are provided for steam conditioning (heating) as per the requirements of next turbine cylinder stage. The heat inputs to re-heaters may be in form of steam, condensate or direct fossil fuel firing. If steam or condensate is used as heat input in the steam re-heater, and the outlet condensate of the re-heater is returned to a boiler for heat recovery, the difference of enthalpy of input steam/ condensate and output condensate should be estimated as input heat.

⁹ While determining the efficiency of baseline turbine in accordance with options A1 and A2, the following guidance can be considered for the loads, that are beyond the grid demand and/or its capacity, and the turbine in project scenario is operated on these loads. For the loads beyond the grid demand and/or capacity of baseline turbine, consider the efficiency to be equal to maximum efficiency achieved over the range of loads.

norms and guidelines (ASME PTC 6-1996 or IEC 60953-3 (2001)) or an equivalent international and national standard). Option C: Use manufacturer's specification of efficiency at optimum load.

Treatment of different fuels being used in the baseline scenario

Note that the most plausible baseline scenario may be that several fuel types would be used in the baseline power plant. As a conservative approach for estimating baseline emission factor where the use of several fuel types is the most plausible baseline scenario, project participants should, select the emission factor of the fuel type with the lowest CO_2 emission factor from the fuels used in the power plant during the most recent three years prior to the implementation of the project activity.

Determination of efficiency of project activity turbine $\eta_{PJ,v}$

The efficiency of project activity turbine can be estimated either by using the following equations or in accordance with the recognized standards for the measurement of the turbine efficiency, such as ASME PTC 6 (1996) or IEC 60953-3 (2001). Step 4: Determine EF_{GRID,y}

The Baseline emission factor for the electricity displaced due to the project activity should be calculated as a combined margin (CM), following the guidance in the approved "*Tool to calculate emission factor for an electricity system*".

Project emissions

The CO₂ emissions from fossil fuel consumption in the project activity (PE_y) should be calculated using the latest approved version of the "*Tool to calculate project or leakage CO₂ emissions from fossil fuel combustion*", where the process *j* in the tool corresponds to the combustion of fossil fuels in the project activity for electricity generation in the project power plants.

In case of steam turbine, where steam generated by boiler(s) is distributed to various users (e.g. turbines) in the plant, following guidance should be used to determine the proportion of fuel combusted in the boiler for the purpose of supplying steam to the project activity turbine.

The proportion of fuel combusted in the boiler(s) for the purpose of supplying steam to the project activity turbine should be estimated on the basis of the ratio of heat input of steam supplied to the project activity turbine to the enthalpy of total steam generated in the boiler(s). Both the steam quantities should be measurable to arrive at a clear estimate of the ratio.

- Where multiple boilers supply steam into common steam headers, all the boilers have to provide the same quality of steam;
- The calculation should be based on the energy supplied to the steam turbine. The enthalpy and the steam flow rate must be monitored for each boiler to determine the energy content of the steam. The calculation implicitly assumes that the properties of steam (temperature and pressure) generated from different sources are the same. The enthalpy of steam will be determined at measured temperature and pressure and the enthalpy difference will be multiplied with quantity measured by a steam flow meter.

Leakage

No leakage is identified under this methodology.

III. MONITORING METHODOLOGY

All data collected as part of monitoring should be archived electronically and be kept at least for 2 years after the end of the last crediting period. 100% of the data should be monitored if not indicated otherwise in the tables below. All measurements should be conducted with calibrated measurement equipment according to relevant industry standards.

In addition, the monitoring provisions in the tools referred to in this methodology apply.





Determining the efficiency of the project activity turbine

The efficiency $(\eta_{PJ,y})$ of turbine in crediting period should be calculated once in a year as per equation nos. 13 or 14, provided in baseline emissions section. If efficiency gains due to further retrofits or replacement or superior preventive maintenance activities exceed maximum efficiency $(\eta_{PJ,max})$ for a particular year, the emission reductions for that year can be claimed only based on the minimum project efficiency of the turbine after implementation of project activity, as per the procedure described in formulae 11 and 12.

Annex 1: Procedure for estimating efficiency (baseline efficiency-load function)

Efficiencies shall be determined through measurements based on performance tests as prescribed by international standards, norms and guidelines (ASME PTC 6-1996 or an equivalent international and national standard). The performance tests shall be conducted for a range of loads that is representative of the situation during the project activity. Based on the data collected from the efficiency determination tests at different loads, the following equation is estimated through regression analysis:

$\eta_{BLI} = f(EG_{PLI}) + 1.96 \times SE(f(EG_{PLI}))$

Each time interval t should have the same duration *T*. In choosing the duration *T*, the typical load variation of the turbine should be taken into account.

The load is estimated as per above equation for each time period t. The efficiency-load function should be derived by applying a regression analysis to all measurements *t* within a range of load factor (or operation mode) that is representative of the situation during the project activity. Measurements should be carried out following national or international standards. It is recommended that project participants apply standard software to apply the regression analysis. More details on the procedure to measure the efficiency at different loads are provided in the monitoring methodology. Each measurement *t* delivers a data pair of electricity generation (EG_t) and efficiency of the turbine (η_t). Project participants should choose an appropriate regression equation to apply to the measurement results. For example, in case of a polynomial function, the following regression equation

In order to ensure that the results of the regression analysis are conservative, the baseline efficiency is adjusted for the upper bound of uncertainty of the result of efficiency-load-function at a 95% confidence level by introducing the standard error SE(f(EG_{PLt})) in equation (1) above. The standard error SE(f(EG_{PLt})) has to be determined for each time interval t. It is recommended that project participants use the standard software to determine the standard error SE(f(EG_{PLt})).




