**Minor issue 1:** The DOE should further ensure the compliance with paragraph 7 of the AMS.III. D v13 by further substantiating use of IPCC values that are used for Western Europe in calculating baseline emissions, or apply values applicable for Brazil as per IPCC Guidelines.

**Minor issue 2:** The CDM-SSC-PoA-DD should be revised to ensure that the MD<sub>fuel</sub> should be calculated using bio gas fuelled (BG<sub>fuel</sub>) instead of bio gas flared.



**Minor issue 3:** Methane conversion factor for Rio Grande do Sul state, within which the part of the PoA will be implemented, should be included in the PoA-DD and CPA-DD, and same should be validated by the DOE.

**Minor issue 4:** The amount of methane recovered and fuelled or flared shall be monitored ex-post, using flow meters, as required by the paragraph 10 of the AMS.III.D v13.

**Minor issue 5:** It shall be confirmed that the combustion temperature will remain above 500 °C when the biogas is used to generate heat or electricity.
