Subject: Host country approval under Clean Development Mechanism (CDM) for Installation of Wind Power Project by Kilburn Chemicals Ltd

Dear Sir,

Kilburn Chemicals Limited (KCL) is a leading producer and exporter of Anatase Grade Titanium Dioxide in India. We produce Titanium Dioxide by the Sulphate route and also manufacture & export the by-product Ferrous Sulphate. Our manufacturing plant is based at the Sipcot Industrial Complex in Tuticorin in the South Indian State of Tamil Nadu.

With the growing concern of cleaner production, Kilburn Chemicals Limited focused on possibilities of undertaking renewable power generation strategies in the existing operations. The company decided to invest in the renewable energy sector by setting up wind mills in the year 2005 as a corporate commitment towards sustainable development. Kilburn Chemicals Ltd installed two towers of capacity 1.25 MW each which could be developed and undertaken through the Clean Development Mechanism (CDM).

The 1.25 MW wind turbine generators are installed in Ukkirankottai and Sundankurichi of Tirunelveli district respectively in Tamil Nadu. The purpose of the project activity is produce power from a cleaner and greener source and in turn to reduce the dependence on fossil fuels for energy requirements. We have signed a power purchase agreement (PPA) with "Tamil Nadu Electricity Board" (TNEB) and export the electricity to the state electricity grid. About 5.6 Million Units per annum is exported to grid from Wind Power, which is wheeled to Kilburn Chemicals Ltd at Tuticorin and utilized for our internal power consumption.

We have developed the PCN (Project Concept Note) for the project activity as per the guidelines of UNFCCC for Greenhouse Gas (GHG) abatement CDM projects for developing countries under Kyoto Protocol. We are enclosing 20 copies of the same for your kind perusal.

We look forward to receiving the host country approval from MOEF under CDM for the above-mentioned project at the earliest.
