Re Request for review of the request for issuance for the CDM project activity "Emission reduction through partial substitution of fossil fuel with alternative fuels like Agricultural by products, tyres and municipal solid waste (MSW) in the manufacturing of Portland cement at Grasim Industries Limited – Cement Division South (GIL-CDS), Tamilnadu, India" (Ref. no. 0339), for the monitoring report covering the activity from 01 April 2005 till 31 March 2006.

SGS has been informed that the request for issuance for the CDM project activity "Emission reduction through partial substitution of fossil fuel with alternative fuels like Agricultural by products, tyres and municipal solid waste (MSW) in the manufacturing of Portland cement at Grasim Industries Limited – Cement Division South (GIL-CDS), Tamilnadu, India" (Ref. no. 0339), for the monitoring report covering the activity from 01 April 2005 till 31 March 2006 is under consideration for review.

Through this letter we would like to comment on the reasons for review and provide additional information. The request for review are all based on the same reason and read:

The spreadsheet for calculating the emission reduction and other attachments mentioned in the Certification Report are not attached. Without the ER spreadsheet, the calculations cannot be verified.

Please refer to the revised monitoring report section III - GHG emission reduction page 14-19 as uploaded on the UNFCCC website. The monitoring report contains the complete data which has been used for the emission reduction calculation. The calculation has been made as per registered PDD (Please refer PDD Annex 4 monitoring plan). The baseline emission factor used for emission reduction calculation is also as per Annex 3 (baseline information) of the registered PDD since the scenario 2 was the most conservative value out of other baseline scenarios.

The spread sheet containing all the information is attached with this letter (attachment 1). The formulas used for emission reduction calculation in the spreadsheet were checked.

We apologize if the initial verification report has been unclear and hope that the information attached to this letter addresses the concerns of the members of the Board.
