Subject: Provisional rates of concession for urea units under the new pricing scheme for the period from 1.4.2003 to 31.3.2004 -- reg.

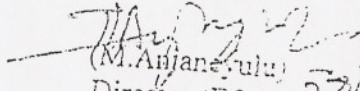
Sir,

I am directed to refer to the Department of Fertiliser's letter no. 12019/5 98-FPP dated 30.1.2003 communicating the new pricing scheme for urea units which has come into effect from 1.4.2003. The rates of concession payable to the urea units during Stage-I of the scheme i.e. for the period from 1.4.2003 to 31.3.2004, have been determined provisionally on the basis of retention prices of urea units as on 1.4.2002, in accordance with the provisions of the scheme outlined in the aforesaid letter dated 30.1.2003. The provisional rates of concession are given in the Annexure and are exclusive of the incidence of sales tax on inputs, which will be separately compensated to each unit as admissible, on the basis of rates effective on 1.4.2002 and the compensation on this account would be proportionately reduced if the rates of sales tax on inputs are reduced by any State. Furthermore, effective 1.4.2003, the units in each group would receive the provisional concession after adjustment on account of escalation/de-escalation in variable cost related to changes in the price of feedstock, fuel, purchased power and water. The modalities for submission of these claims will be communicated separately.

2. Provisional subsidy claim bills for the month of April, 2003 and thereafter may be submitted on the basis of the provisional rates of concession as given in the Annexure and the actual sales tax paid, as admissible. The bills may be submitted in the proforma prescribed for the purpose by the Office of FICCI.

3. This issues with the concurrence of the Integrated Finance Division, DOF vide Dy. No. 987/FA/03 dated 26.5.2003.
