
### 1.0 SCOPE OF WORK:

The scope of work includes but not limited to providing Carbon Advisory Services and Clean Development Mechanism (CDM) Project Development Services for Carbon Credit Generated through recovery of CO2 from Flue Gas of Reformer Stack at Phulpur & Aonla Plant and Fuel & Feed Switch from Naphtha to Natural Gas at Phulpur Plant.

## 2.0 FEES STRUCTURE:

- 2.1 Fixed fee for these two schemes will be as under:-
  - A) CO2 recovery from flue gas at Phulpur & Aonla plant.

B) Fuel & Feed switch from Naphtha to Natural Gas at Phulpur Plant

- 5.2 The performance under this contract shall not stop for any reason whatsoever during the said dispute/proceedings, unless you are specifically directed by IFFCO to desist from working in this behalf.
- 5.3 The venue of arbitration shall be Delhi
- 5.4 The language of proceeding shall be English.
- 5.5 The Law governing the substantive issues between the parties shall be the Law of India.

#### 6.0 TERMINATION:

The Contract can be terminated by either party by giving notice in writing. In case IFFCO terminate the contract after validation and registration of project with UNFCCC or entering into agreement with carbon credit buyer proposed by E&Y, whichever is earlier, INR
