- The above revised concession & sales tax rates are notified subsequent to FICC board decision on various issues in supersession of concession rates notified earlier for the above period.
- You may prefer your claims based on the revised concession rates, in the proforma prescribed by the FICC. Reduction in subsidy on account of downward revision of concession rates may be duly adjusted in the arrears bills or fresh bills to be preferred with the FICC and in case no payments are due from the Government, the amount be refunded to the Government by due date.
