## **COMPANY PROFILE**

### **DANS GROUP OF COMPANIES**

The DANS group of companies is engaged in the development of hydro-electric power projects and providing consultancy services to other major hydro-electric power projects. The group currently has interests in following projects:

#### **Jorethang Loop Hydro Electric Project**

The DANS group owns the Jorethang HEP - a 96 MW project based in Sikkim, which is the subject of this Preliminary Information Memorandum. The group has created a company DANS Energy Pvt Ltd for the development of this project.

#### **Ting Ting Hydro Electric Project**

The group also has interests in a 90 MW Sikkim based project, and incorporated a company – TT Energy Pvt. Ltd. in the year 2006 for its development. Preliminary investigations have been completed and the Detailed Project Report (DPR) has been submitted to the Govt. of Sikkim for approval.

#### **Tashiding Hydro Electric Project**

The DANS group has also been allotted an 88MW project by the Govt. of Sikkim to be developed on a Build-Own-Operate-Transfer (BOOT) basis. Another company – Shiga Energy Pvt. Ltd. has been incorporated for this project, and is in the process of conducting preliminary investigations for preparation of the DPR.

The DANS group of companies incorporated DANS IT Systems Pvt. Ltd. under the Companies Act, 1956 on February 20, 2003 with the objective to conduct business mainly in the areas of e-business, web page design and maintenance, network management, computer software and hardware.

Considering the increasing opportunity in the power sector, the company passed a resolution in an Extra Ordinary General Meeting in August 2005 and renamed the company as DANS Energy Pvt. Ltd. The new name was registered in October 2005, with modified objectives, which include the following:
