Reasons for request:

1. The DOE is requested to clearly state on what basis it has considered that the barriers listed in the PDD would prevent the implementation of this project activity, and the PP is requested to explain why the project activity was commenced prior to being submitted for validation if the barriers are to be considered prohibitive.



2. The common practice analysis has not been conducted in accordance with the Tool for the demonstration and assessment of additionality. The DOE is requested to clarify how this section of the PDD has been validated and considered to be appropriate.
3. The DOE shall clarify why the PDD submitted for registration does not contain information regarding the prior consideration of the CDM as required by the guidelines for completing the PDD.
4. The DOE shall provide further details regarding how it is satisfied that the CDM was seriously considered in the implementation of this specific project activity.
5. The DOE is requested to provide further information regarding how it has validated that the gas has been flared for the previous three years and not vented.
6. Further information is required regarding what steps will be taken if the monthly analyses of carbon content indicate significant variations
