TEMPORARY AGREEMENT

BETWEEN

PT Dwarakarsa Priamarta (DPSOLUSI)

Herein after referred as the First Part

AND

PT. SEMEN CIBINONG, Tbk

Herein after referred as the Second Part

This agreement, in the absence of a formal contract, binds both of the aforementioned parties in relation to the provision of the services described below under the terms and conditions set forth in the following paragraphs. Once the formal contract is issued, this agreement is no longer valid.

Required Services

The First Part undertakes to provide support for the preparation of the Second Part's CDM project including the preparation of required documents by PCF and UNFCCC for CDM project registration and assistance to CDM approval. The required documents are:

- Pre-feasibility study
- Feasibility study
- Environmental Management Plan, for all Second Part's facilities (Narogong and Cilacap, West Java)
- Project Design Document

The First Part also undertakes to assist the Second Part during discussion and communication with the PCF and the UNFCCC Executive Board and Methodology Panel, if required, until the PDD is registered.

Cost

The required services shall be provided for a lump-sum fee of US\$ 50,000. The first part will not exceed this total cost prior to authorization from Semen Cibinong.

Others

Other binding issues regarding cancellation of work, liabilities, arbitration, delivery and invoicing shall be detailed and settled in the formal contract.
