Reasons for request:

1. More information should be supplied as to why the importation of electricity from the grid cannot be considered a viable alternative to the project. Clear substantiation should be provided as to why the continuation or expansion of the current energy supply system has not been considered as an alternative to the project activity. The PDD should only indicate barriers which relate to the project activity and not those which are generic to any alternatives and should transparently describe that such barriers cannot be overcome without CDM.
