The Board was informed about the Kyoto Protocol and Framework Convention on Cliamte Change. S. R. Mishra, Director was of the view that Company is likely to be eligible to get Carbon Credit benefits because most of the power produced in India is thorough Thermal Power Project. The Chairman said that with the permission of Board, the company could explore the possibilities of Carbon Credits benefits for upcoming 3.0 MW Hydro Power Project. The Board approved the proposal and passed the following resolution unanimously:

Khungar, Director has identified scope for expansion of the capacity by 1.9 MW at the present project site. On being asked specifically, Ms. Ritu Kohli, Director on the Board of the Company apprised that despite the best effort, she could not identify any suitable consultant for CDM benefit but she also added that subject to the approval of the Board, the company may consider Carbon Credit mechanism for the expansion of capacity as and when it happens. The Board approved the proposal and passed the following resolution unanimously:

"RESOLVED that the proposal to carry out carbon credit as per the norms of CDM Authority of India and United Nationas Framework Convention on Climate Change be and is hereby approved."

EXTRACTS OF MINUTES OF MEETING OF THE BOARD OF DIRECTORS OF M/S. K.K.K. HYDRO POWER LIMITED DULY CALLED AND CONVENED AT ADMINISTRATIVE OFFICE AT I-41, DLF INDUSTRIAL AREA, PHASE-1, FARIDABAD ON WEDNESDAY, 18TH DAY OF AUGUST, 2004.

Mr. Pawan Kumar Kohli, Chairman apprised the Board that production of 3.0 MW has finally commenced on 5th August, 2004 but the management could not get convinced with the proposals of any consultant to carry out Carbon Credit related studies. He stressed that in view of possible expansion from 3.0 MW to 4.9 MW, it would be advisable to take Carbon Credit Study for the expanded capacity as a single entity. The other Directors present in the meeting totally agreed to the proposal of Mr. Kohli and thereafter, the following resolution was passed unanimously:

"RESOLVED that the proposal to carry out carbon credit study for the Baragaran Hydro Power Project 3.0 MW being expanded to 4.9 MW as per the requirement of Designated National Authority and United Nations Framework Convention on Climate Change be and is hereby approved."
