

..... The documents and records, upon submitted by the ESE, Electrical Circle,
Chailasa - we above referred to undersigned is pleased to accord sanction of 1500 kVA load on 33KV
to you at works of Bulandih, Mouza- Dhunaburu P.O. Chandil Dist: Sarakela Khasawan with
the terms and conditions as enumerated here under:

1. You shall have to execute an agreement in the prescribed form of the Board in the office of the ESE, Electrical Supply Circle, Chailasa on any working day.
2. The Security amount as calculated and asked by the office of ESE, Chailasa on 1500kVA load in tariff will have to be deposited by in the shape of Bank Draft / Bankers cheque in the office of All Electric Supply Sub-Division, Chandil on any working day.
3. The estimate for the construction of 33KV feeder (Independent) and other works you have to deposit by you in the office of Asstt. Elect. Engineer, Electric Supply Sub-Division, Chandil on any working day.
4. You shall have to procure power transformer with ISI Mark for installation. If the total capacity of power transformer and auxiliary transfer if any shall not exceed 150% of the sanctioned load, if the capacity of the transformer was found to be more than 150% of the sanctioned load i.e. 2250kVA power shall not be supplied to your plant.
5. Suitable metering arrangement for installation of CT, PT, units etc shall have to be done.
6. You shall have to install shunt capacitor of Adequate Capacity of ISI mark so as to maintain power factor of minimum 0.85.
7. You shall have to obtain and submit statutory clearance from electricity department of Jharkhand, Ranchi in respect of your Electrical Installation and equipments for which you are liable to apply before Electrical Inspector, Govt. of Jharkhand Ranchi.
8. You shall have to clear all outstanding dues, if any, against the authority before signing the agreement.
9. You shall have to abide by Board's Tariff as applicable time to time.

10. You shall have to submit a copy of the purchase document with invoice and test report of the equipments like transformers panels and protective devices before execution of agreement.
11. Metering unit of appropriate capacity and specification will have to be arranged by you if the same is not available in Board's stores.
12. Further conditions if so required will be communicated to you.
13. All the above-mentioned formalities are required to be completed within three months from the date of issue of this letter failing which this load sanction shall automatically stand cancelled.
