The Executive Chairman informed the Board that as per the Main Objects of the Company vide sub-clause No.6 of the Memorandum of Association of the Company, the Company was empowered to setup/undertake power generation projects. The Board discussed the matter and noted that as per the extant policy of the Government of India, there was a commitment by the State Government to pay a certain tariff upto 2003 – 04 for the power exported by the Power generating units and thereafter, the rates to be paid would be refixed. The Board discussed the matter and considered taking up a bagasse based Cogeneration Power Project for the production of 20 MW power using Turbo Generators and noted that M/s. Avant Garde, Chennai had been appointed to prepare a Detailed Project Report (D P R). Since the details would be firmed up only in due course and also since it was proposed to import a second hand steam turbine generator, it was decided to in principle approve the proposal and pass the following resolution:
