In case of using Bagasse, sugarcane juice is found about 50% therein, which may damage super heater tubes.

So, in both the above cases, we do not guarantee for the life of the boiler.

On the other hand, Coal is better fuel for the boiler. We suggest you to use coal as fuel whereon we can assure you for a very good life of your Tubes & boiler.
