On the Notice of Holding the Clean Development Mechanism (CDM) Project Proseminar

In order to mitigate the impact on the sustainable development of the world caused by the emission of Greenhouse Gases (GHG), various countries signed *The Kyoto Protocol* in Tokyo, Japan on December 1, 1997, which permits the cooperation between developed countries and developing countries on GHG emission reductions.
