Please refer our letter No.DSIL:DN:Cogen:4760 dated 26<sup>th</sup> July, 2007 addressed to you and copy endorsed to all concerned, sent through UPC, vide which we had requested about the transmission line from our Dwarikesh Nagar unit to Najibabad Grid which needs more repair on items like Insulators, earth wire and poles support. Trimming of trees is very essential and painting of poles which has not been carried out for last so many years and last year inspite of our vigorous persuasion and repeated request, painting of poles was not done, therefore, which should be done positively this year to maintain its life. Due to improper maintenance we are facing lot of tripping problem and factory as well as UPPCL is suffering financial losses.

We would again like to inform you that this transmission line laid down by UPPCL on our cost. To maintain this transmission line, as per Power Purchase Agreement UPPCL deducts 1.5% amount of the total cost of the line from the bill of April in beginning of each Financial Year. For Financial Year 2007-08, an amount of Rs.1,43,805/- has also been deducted from the bill of April, 2007 for the maintenance of bay and 33 KV Transmission line.

We once again request you to kindly take up the maintenance work of the transmission line at the earliest to avoid any untoward incident and ensure smooth supply.

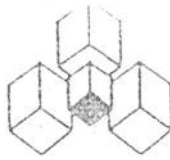

Dear Sir,

We are evacuating 8 MW electricity from our Dwarkesh Nagar Sugar Unit to your Grid at Najibabad. The transmission line has been laid down by UPPCL on our cost. To maintain this transmission line UPPCL deducts 1.5% amount of the total cost of the line from the bill of April in beginning of each Financial Year. The deduction details are given below:-

Many letters have been written to the office of UPPCL to maintain the line but till date no maintenance done by UPPCL. This transmission line is in very bad shape. Most of the places are corroded. Some of the foundations are broken. Most of the poles earthing wire disappeared and insulation of conductor is to be replaced. As you are aware, the electricity is being evacuated to the grid at very high voltage and if any fault occurs, it will be dangerous for the public.

We have received a letter no.1703 dated 27<sup>th</sup> February'2006 from Mr. P K Goel, General Manager, Paschimanchal Vidyut Vitran Nigam Limited, Moradabad to contact to your good office for getting the transmission line re-strengthen/maintain at the earliest (copy of letter attached).

Therefore, we request you to kindly start maintenance work of the transmission line at the earliest to avoid any incident and to ensure smooth supply.



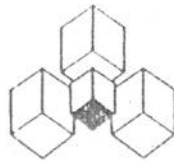

On hearing the petition no 220/2005 of UPPCL, UPERC dismissed the petition by giving the reasons for allowing the escalation for FY 2003-04 and 2004-05 for second phase (Copy Enclosed). After getting the order dated 24/02/05 vide our letter No 1300 dated 03/03/05 we again requested CGM PPA, UPPCL for passing our bills in accordance with UPERC order, but no instructions had been issued from UPPCL head office to comply with the UPERC order and , Bijnor office not only deducted the escalation for FY 2003 04 & 2004 05 but also not give the escalation for FY 2005-06.

In the mean while UPPCL has filed an appeal in High Court Allahabad at Lucknow bench against the above mentioned order , case came up for hearing on 06/05/05 and Court declined to stay the order passed by UPERC. As on date, there is no order in favour of UPPCL, by virtue of which our payment with escalation may be stopped.

Based on the agreement we invested a huge amount in setting up the Co-generation facilities by taking loans from banks and financial institutions, now if UPPCL reduces the rates, we shall be put into huge loss.

Therefore, we humbly pray that suitable direction may kindly be issued to CGM PPA to verify our evacuation bills in totality without deducting any amount.

Dear Sir,


We regret to inform you that the maintenance of power line provided to transmit from our cogeneration unit of 8.0 MW at our works Dwarikesh Nagar to Najibabad Sub-station is having very poor condition causing frequent stoppages and poor transmission. Though, we are paying maintenance charges @1.5% on the total cost involved at the time of installation of the line. However, whenever we pursue this matter with the concerned authorities for better and proper line maintenance, they always say that they are not having funds for this purpose. We fail to understand, when we are making regular payment for the specific purpose why it is getting defeated.

We are also enclosing a copy of letter vide no.608 dated 20.06.2005 sent by Dy. General Manager, Vidyut Ayat-Niryat and Bhugtan Mandal, UPPCL, 11<sup>th</sup> Floor, Shakti Bhavan Extension, Lucknow addressed to Executive Engineer, Najibabad and copy of letter vide no.402 dated 06.06.2005 of General Manager (PPA), UPPCL, Lucknow, addressed to General Manager (Distribution), Moradabad Region, Paschimanchal, Vidyut Vitran Nigam Ltd., Moradabad on this issue for your reference. However, no action has been taken so far even after issuance of these letters.

Therefore, you are requested to kindly look into this matter for needful done at appropriate level so that we may not face any problem for the smooth transmission of power from our Cogeneration Plant to Najibabad sub-station which will also be in larger Public Interest.
