The total contract price is inclusive of the cost of inter alia the following -

Cost of all other items which are necessary for completing the supply of equipment and accessories as per scope of supply.

Custom duty if any on imported raw material, assemblies, sub-assemblies or any other component and services forming part of scope of supplies.

All taxes, duties and Octroi to be paid by the SELLER or their sub-contractors on raw materials, components and other materials for their own manufacture of finished machinery and equipments or part of said machinery and equipments.

Packing and forwarding charges, royalties and fees if any, loading charges, freight upto the site & transit Insurance.

Supervision for Erection & Commissioning charges.

But exclusive of Excise duty & sales tax

Applicable statutory forms wherever required, will be issued by the Purchaser to the Seller. The contract price is firm and fixed till the contractual completion of the contract. Under no circumstances escalation in price is contemplated and become payable by the purchaser.

TERMS OF PAYMENT :

The Purchaser will pay the seller the contract price as detailed hereunder:-

1. Rs.7.85 Lacs (Rupees Seven Lacs Eighty Five Thousand only) being 5% as 1st advance shall be paid against submission of advance bank guarantee for equivalent value valid for the entire contract period on as per purchaser's format and acceptance of order.
2. Rs.7.85 Lacs (Rupees Seven Lacs Eighty Five Thousand only) being 5% as 2nd advance shall be paid against submission of advance bank guarantee for equivalent value valid for the entire contract period as per purchaser's format, system configuration, panel drawing, data sheet, basic loop drawing, bar chart, project schedule. Supply schedule, G.A.Drawings, billing schedule, in house fabrication schedule, a checklist/ time schedule for placement of order for the bought out items.

Unpriced Purchase Order copies shall be submitted progressively, detailed IO, wiring drawing and cable requirement will be submitted within 45 days from the date of our LOI no.DSIL/DP/160/0996 dated 30th September'06.

3. Rs.102.05 Lacs (Rupees One hundred and Two Lacs Five Thousand only) being 65% along with applicable taxes and duties after receipt of materials at site in 45 days subject to satisfactory inspection by our site engineer and starting of erection works.
4. Rs.15.70 Lacs (Rupees Fifteen Lacs Seventy Thousand only) being 10% after satisfactory completion of erection.
5. Rs.23.55 Lacs (Rupees Twenty Three Lacs Fifty Five Thousand only) being 15% payable after commissioning, trial run, reliability run and performance testing and against submission of performance bank guarantee as per purchaser's format of the equivalent amount valid for the entire guarantee period up to June' 2009.

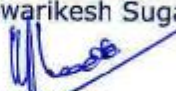
