1. Further clarification is requested from the DOE on the level of assurance with which it has validated the CDM consideration, in particular with regard to the means of validating the closure of CAR5.



2. Para B.5.13 of the VR states: “Minutes of Board of Directors meeting dated 9th and 10th January 2003 has been submitted. This demonstrates that the CDM was considered in the management decision for implementing the project activity”.

This however is not sufficient evidence to demonstrate that CDM was seriously considered at the start of the project. More evidence is necessary to demonstrate how it was considered that the expected additional income from the CDM was essential for the decision to go ahead with the implementation of the project activity. This evidence shall also be validated by the DOE.

3. Further clarification is required on how the appropriateness of the input values to the cost calculation, in particular the use of inconsistent values for coal consumption in the cost analysis (5,269 T/year) and the emission reduction calculations (6,807 T/year), have been validated.
4. The DOE is requested to confirm that the procedure of measurement of flow rate and specific heat of the hot air to the spray dryer is reliable enough to guarantee a accurate emission reductions.
