### Notice Regarding the Relevant Issue about the Grid Power Price of the New Operation Hydropower Units in Gansu Province

Price bureaus of cities and prefectures, Gansu Electric Power Corporation:

According to the notice regarding the issues about solving the contradiction of power price in Northwest grid (Fa Gai Jia Ga [2004] No.1125), issued by National Development Reform Commission, and the application submitted to NDRC, the notice on issues about the provincial to-the-grid power price of newly operated hydropower units is as follows:

- 1. In accordance with the national regulations, since 1st January 2005, the to-the-grid power price of the provincial newly operated hydropower units (regardless of installation capacity) which are under the unified dispatch of the provincial level grid, should be performed according to the to- the- grid benchmark tax-included price of Gansu provincial newly operated hydropower units stipulated by the national regulations, i.e. 0.227 RMB/kWh currently. The list of the newly operated units complied with national regulations is shown in the schedule..
- 2. For the provincial hydropower stations operated prior to 1st January 2005, the to-the-grid power price of those with the individual total installation capacity below 50,000 kW is still 0.18 RMB/kWh in accordance with the regulation in the notice regarding increasing the to-the -grid power price of small hydropower stations Gan Jia Shang [2004] No 352, issued by provincial price bureau.


各市、州物价局、省电力公司:

二、省内2005年1月1日以前投产的单个电站总装机容量为 5 万千瓦以下的水电站,其上网电价仍按省物价局《关于提高小 水电企业上网电价的通知》(甘价商[2004]352号)规定的小水电 上网电价 0.18 元/千瓦时执行。
