## **COVER NOTE**

### **1. Procedural background**

1. The mandates of the CDM Accreditation Panel (CDM-AP) are determined by their terms of reference, the rules of procedure of the CDM Executive Board (hereinafter referred to as the Board) of the clean development mechanism (CDM), and additional guidance provided by the Board in the course of the year, including in the approved workplan developed within the context of the CDM business and management plan 2020–2021.
2. The practice of the Board is to adopt the workplan of the CDM-AP at the first meeting of the year, in order that the mandated work for 2020 is clear and transparent.

### **2. Purpose**

3. The draft workplan of the CDM-AP for 2020 provides an overview of the expected activities of the panel. This ensures a balanced workload throughout the year and efficient use of meeting time.

4. The draft workplan of the CDM-AP for 2020 provides details of the activities, expected outputs and timelines for finalizing the recommendations and deliverables for the Board's consideration. The workplan is in accordance with the draft workplan of the Board for 2020.

6. Once approved, the workplan of the CDM-AP for 2020 will be updated continuously and the status on the implementation of the workplan will be reported to the CDM-AP and its chair and vice-chair.

## **1. Introduction**

1. The support structure of the Executive Board of the clean development mechanism (CDM) (hereinafter referred to as the Board) consisting of the CDM Accreditation Panel (CDM-AP), the Methodologies Panel, the Afforestation and Reforestation Working Group and the Carbon Dioxide Capture and Storage Working Group is established under the Board to assist in the performance of its functions related to the accreditation system and methodological issues concerning CDM activities.
2. The mandates of the panels and working groups are determined by their terms of reference, the rules of procedure of the Board, and additional guidance provided by the Board.
3. The workplan of the CDM-AP for 2020 outlines the expected tasks to support the Board and has been developed within the context of the CDM business and management plan 2020-2021. The workplan includes the routine operational activities to be performed by the CDM-AP as well as mandates from the Board.
