#### Back ground.

Proposed Programme CDM is implemented at jeju special self-governing province, Republic of Korea and the title is "The programme to introduce renewable energy system into jeju island (hereinafter refer to as the Jeju PoA)".

CME for this PoA designed the programme that involves photovoltaic system, wind power and small hydro power in order to achive the goal that spread the renewable technology in the Jeju island.

This PoA applies small scale methodology AMS-I.D and AMS-I.F.

It explains about photovoltaic system, wind power and small hydro power in PoA-DD and generic CPA-DD. but there is explanation only about photovoltaic system in Specific CPA-DD.

#### Query 1.

- We have two methods for making generic CPA-DD. Which method is more reasonable?
  - (1) PP makes generic CPA-DD for each technology

    (i.e, when PP applies three technologies like this proposed PoA (photovoltaic, wind power, small-hydro power), PP makes three generic CPA-DD.)
  - (2) PP makes just one generic CPA-DD including all technologies

    (i.e, when PP applies three technologies like this proposed PoA (photovoltaic, wind power, small-hydro power), PP make just one generic CPA-DD including all technologies.)

#### Query 2.

- If PP already prepared Specific CPA-DD only for photovoltaic system and didn't prepare Specific CPA-DD for the other technologies, is it possible to proceed with registration activity of PoA in this situation?

That is, PP wants to proceed with validation and registration activity in the situation where only Specific CPA-DD is prepared for photovoltaic system and PP has a plan to add new CPA related to wind power and small hydro power project to this PoA after its registration, so is it possible to validate these two types of CPA in future to add them into registered PoA?
