The purpose of this letter to EB concerns the following two issues on the project entitled “Wind farm extension project for Lafarge’s cement plant in Tétouan” in Morocco, which is under validation by the DOE and on Internal Technical Review:

1. There is a minor editorial error regarding the name of PP between the PDD and MoC (Lafarge Ciments) and the LoA (LaFarge Ciments). The “f” letter in Lafarge is written in capital letter in the LoA. The technical reviewer of the DOE requests a new LoA, when the lead validator thinks it is unnecessary. However, it is unlikely that the PP will receive the revised LoA on a short notice as it has to be signed by the Moroccan Minister of Environment. Is this minor editorial non conformity could affect the registration of the project when the request of registration will be submitted to the EB? And is it necessary to ask for a revised LoA from the DNA?

2. The second issue concerns the version to be used of the “tool to calculate the emission factor for an electricity system”. The DOE requests to update the version of the tool to the latest one (version 2.2.1) in the PDD, when the PP is using the tool version 2.1 on the ground that this version (2.1) is still active on the UNFCCC website and according to para 36 of the "*Procedure for the submission and consideration of requests for revision of approved baseline and monitoring methodologies and tools for large scale CDM project activities (version 01)*", if correctly interpreted/understood, version 2.1 of the tool is valid until 29 May 2012 (8 months after publication of the latest version). Is it still necessary to update the tool in the PDD to the latest version 2.2.1?

Please provide any specific suggestions or further information which would address the issue raised in the previous section, including the exact reference source and version (if applicable).
