The Project Participant - Corporación Masbosques - in the San Nicolas CDM Reforestation Project (9390), respectfully requests a clarification on the reasons why the request for registration of CDM project activity during the secretariat's completeness check, was deemed as incomplete, taking into account the delivery on time of the information requested by the UNFCCC Secretariat:

1. On May 17 (Date: Fri, 17 May 2013 05:43:53 -0500) the CDM Team requested a replicable version of the spreadsheet for the assessment of the investment analysis as required by Guidance 8 of EB 51 Annex 58. The investment analysis was not carried out in the San Nicolas CDM Reforestation Project (9390), since for the particular conditions of the project area, the barriers analysis was the most appropriate method to undertake the additionality analysis in the project. The entire procedure was done according to the "combined tool to identify the baseline scenario and demonstrate additionality in A/R CDM project activities".
2. On May 17 (Date: Fri, 17 May 2013 05:43:53 -0500) the CDM Team requested an unprotected versions of the spreadsheets Appendix 1 - TARAM_V1.3_SN_P2 and Appendix 2 - TARAM_V1.3_SN_P1. The deadline to provide this information requested was 21 May 2013 17:00 CEST. The DOE representative (Julio Alejandro Giraldo, ICONTEC) answered this request sending the two files unprotected on May 20, as follows:
