We are a PP who has invested in wind project of 31.5 MW capacity. During our board decision in March 2013, we have decided to go ahead with the wind project considering CDM benefits. Our Purchase order was issued by end of April 2013. In line with the prior consideration guidelines we had decided to intimate to UNFCCC using the FORM. Even now our land is not yet confirmed due to which the supplier has delayed the erection and commissioning due to unforeseen reasons. At this stage we are even considering even shifting the location to a different state. Hence we would like to clarify if the FORM needs to be submitted mandatorily within October 2013 with the precise coordinates (which we don't know as of now) or mentioning only the project title and later stages we would intimate again the precise coordinates in the prescribed form. In such case would that be regarded as an incomplete submission. Your advice in this regard would be very helpful as we as PP realise the notification is a mandatory requirement and we wish to follow the requirements.
