Dear Secretariat,

Currently, we are a part of a CDM bundled wind project (8 nos x 2.1 MW). Pls. consider the following events are as follows:

In our company Minutes of meeting for investment decision for 7 WTGs on 1st June 2008 we had appointed a bundler to act on our behalf for CDM related activities. Another investor took decision on the same day for his one WTG (1x 2.1 MW).

The Start date of the bundled project activity is 8th July 2008 (Earliest start date) based on the PO issued by the another investor (1 x 2.1 MW). For our other 5 x 2.1 MW WTGs, we issued purchase order on 14th July 2008. Subsequently we issued Purchase order for 2x2.1 MW capacity WTGs on 1st September 2008. Delay was due to some negotiations that was the reason it took some time to issue purchase order for those 2 WTGs which is a common phenomenon in India.

Since the start date of the bundled project activity itself falls before 2nd August 2008, we had not intimated to either UNFCCC or NCDMA. Now we have been asked to withdraw those 2 WTGs (whose dates of purchase order falls after 2nd August 2008) from the bundle by the bundler as we have not intimated to UNFCCC or NCDMA within the 6 months' time period.

We have already incurred consultancy fee and validation fee but project is not moving for long period. Finally, our Board took this step to get the clarification from your esteemed organization. Kindly advise us.
