Dear Secretariat,

This is Wooam, Inc., and we are writing to ask for leniency regarding CDM registration. We are preparing PPD and we have a short question regarding prior consideration. In accordance with the para, 107 of VVS ver05.0, project proponent shall notify the secretariat and the host Party DNA regarding the commencement of a new project activity within 180 days of the project activity start date. If such notification has not been provided by the project participants, DOE shall determine that the CDM was not seriously considered in the decision to implement the project activity.

What if the PP notified the prior consideration to the DNA and the secretariat 186 days after the project start date instead of 180 days?
Shall the DOE publish negative validation report? There were some kind of miscommunications between the PP and a consulting company, so the PP passed the deadline several days. The project is a small scale photovoltaic power generation project and it is in the positive list.

Project information:
The PV purchase contract was signed dated 17. Aug 2012(Starting date) and the notification to the UNFCCC and DNA was made dated 18. Feb. 2013.
