This is a request in regards to procedures of Correction in Post-registration change. According to our understanding, the changes do not require prior approval by the board (Clean Development Mechanism project standard EB65, Para 206 and Appendix 1. Clause 1, covered by ref. 1 i.e. such corrections may include typographical errors, locations, names and number of components, etc.).

In case of corrections that do not affect project design, we think, the period of review by secretariat is shorter than others because it does not require prior approval by the board.

- What are the steps of review by secretariat and board? Does it need to follow all the procedures mentioned in para 140 – 156 in clean development mechanism project cycle, EB 70?

In the PoA (Ref. 5019), process track is "Prior approval" and current status is "summary note being prepared". The only a modification made is the definition of streetlight that was not wide enough in the earlier version to cover all lights installed on a road. This is a minor change and correspond to the correction according to the Clean Development Mechanism project standard EB 65.

- The POA, Ref 5019, according to the current status in the UNFCCC portal, is seemed to be needed the "prior approval" against our expection.
- What is the next pharse? And does it require the prior approval?
