According to the Glossary of CDM Terms (version 7.0), the starting date of PoAs shall be considered as "the date on which the coordinating/managing entity officially notifies the secretariat and the DNA of their intention to seek the CDM status or the date of publication of the PoA-DD for global stakeholder consultation in accordance with the relevant CDM rules and requirements." The CDM Project Standard (version 7.0) also states: "The following applies instead of paragraphs 65–66 above: The coordinating/managing entity shall determine the start date of the proposed CDM PoA and provide a description of how the start date has been determined. The start date of a PoA shall be either of the two dates below: (a) The date of notification of the intention to seek the CDM status by the coordinating/managing entity to the secretariat and the DNA; or (b) The date of publication of the PoA-DD for global stakeholder consultation." The CDM Project Cycle Procedure (version 7.0) also states that "the coordinating/managing entity may notify to the DNA(s) of the host Party(ies) of the PoA and the secretariat in writing of the intention to seek the CDM status for the PoA, using the "CDM programme of activities prior consideration" form (CDM-PoAP-FORM) for the purpose of determining the start date of the PoA." Considering the statements above, the nature of the definition of the PoA starting dated is to ensure that PoA has been developed under the CDM framework while considering the carbon credits revenues. However, what happen in the case of a PoA for which methodology is developed specifically for its case? To the understating of the Project Participants, in case of CME has developed a specific methodology for the proposed PoA, then, this date can be considered as the PoA starting date. Then, the Project Participants request clarification regarding this issue and, revision of the Glossary of CDM Terms if this understanding is applicable.
