Clarification are as –

a. We need to clarify that if the project start date is of date prior to 1 April 2015, when the Project Standard Ver09 was not adopted, then Project participants were not having mandate or guideline to conduct Local Stake Hodler Meetings and now if they want to get their project registered then would it not be allowed ?

Is there any provision for permanent removal of bundle partners, who are not interested to get into verification?</p> <p>Question 03 – Share of Proceeds Since in the present scenario demand of credits issued before 31 Dec 2012 is very low. If project is registered on 01 Jan 2010 and wishes to get verification of monitoring period from 2 Jan 2010 to 1 March 2015 i.e. two periods as -</p> <ol style="list-style-type: none"> 1. Before 31 Dec 12 – 1 Jan 2010 to 31 Dec 12 2. After 1 Jan 13 – from 1 Jan 13 to 1 March 15 <p>Project participant wishes to pay Share of Proceeds for the credits issued from 1 Jan 13 to 1 March 15 since they are tradable but don't want to pay SOP for credits issued before 31 Dec 12 since they don't have market demand, once demand will come it shall be paid.
