- 6. The SSC WG recommended that the Board <u>approve</u> the following revised draft small-scale methodologies:
  - (a) "AMS-III.D: Methane recovery in animal manure management systems", as contained in <u>annex 1</u>. The revision was carried out in response to the mandate received from the Board at EB 83 (EB 83 report, para. 32; MAP project 223). The SSC WG, at SSC WG 48, requested the secretariat to make the draft revised methodology publicly available for global stakeholder consultation for the period from 11 July to 8 August 2015. No inputs were received. The draft revision includes non-binding best practice examples;
  - (b) "AMS-III.H: Methane recovery in wastewater treatment", as contained in annex 2. The revision was carried out in response to the mandate received from the Board at EB 83 (EB 83 report, para. 32; MAP project 223). The SSC WG, at SSC WG 38, requested the secretariat to make the draft revised methodology publicly available for global stakeholder consultation for the period from 11 July to 8 August 2015. No inputs were received. The draft revision includes non-binding best practice examples;

## Agenda item 2.3. Consultation on issues related to methodological standards

- 7. The SSC WG recommended that the Board <u>take note</u> that it provided input to the secretariat on draft concept notes, developed under project 244 "Development of new methodologies to broaden the applicability of the CDM" in response to the mandate from the Board at EB 82 (EB 82 report, annex 7) and as included in the workplan of the SSC WG in 2015:
  - (a) Methodology for integrated mitigation action at the city level (revised title: Exploration of methodological options for developing Urban CDM);
  - (b) Broadly applicable highly useable methodology for transport applications.

#### Agenda item 2.4. Other Issues

8. The SSC WG recommended that the Board <u>approve</u> the draft revisions of the guidelines "General guidelines for SSC CDM methodologies" and the tool "Demonstrating additionality of microscale project activities", as contained in <u>annex 3</u> and <u>annex 4</u>. The

revisions were carried out in response to the mandate received from the Board at EB 85 (EB 85, para. 42), to start implementing option 1 and option 3 indicated in the concept note "Thresholds for microscale activities under programmes of activities" (Annex 9 of EB 85 annotated agenda). The EB 85 requested the secretariat, to enable applying microscale thresholds at the unit level, in the context of paragraph 18 of decision 4/CMP.10 and paragraph 12 of decision 3/CMP.9.
