7. The A/R WG considered submissions of requests for clarifications to approved afforestation/reforestation (A/R) methodologies. The A/R WG recommended that the CDM Executive Board (the Board) <u>approve</u> the response to the request for clarification as agreed by the A/R WG and available on the UNFCCC CDM website for the case specified as "clarified" in table 1 below.

- 9. In response to the submission "SSC_AR_010: Clarification on the guidance to be used to prove 'Barriers due to prevailing practice' as allowed for in Methodology AR-AMS0007 (version 3.0)", the A/R WG agreed to clarify that the "Guidelines on additionality of first-of-its-kind project activities", EB 69, annex 7, version 02.0 do not apply in the case of A/R CDM project activities. As mentioned in footnote 1 of those guidelines, the measures identified in paragraph 2 of the guidelines do not cover A/R activities. Further, the operational paragraph of the guidelines, namely, paragraph 5, does not have meaningful interpretation in the case of A/R activities.
- 10. The A/R WG agreed that project participants may use any approach, general or specific, to demonstrate the existence of a barrier, including the barrier of "first of its kind". As stated in paragraph 1(e) of appendix 1 to methodology AR-AMS0007, the project participants are only required to demonstrate that "no project activity of this type is currently operational in the host country or region" as evidence of existence of the barrier of "first of its kind".
- 11. The A/R WG also agreed that for more general approaches to the demonstration of existence of barriers, project participants may draw upon the "Guidelines for objective demonstration and assessment of barriers" (EB 50, annex 13), although application of these guidelines is not mandatory.

Agenda item 3.2. Other matters

- 12. The A/R WG recommended that the Board <u>take note</u> of the inputs related to the rationale that would justify the continuation of exceptions allowed for afforestation and reforestation (A/R) project activities and A/R programmes of activities (PoAs) as indicated in paragraph 128(c) and footnote 18 of the "Clean development mechanism project standard" version 04.0. The A/R WG agreed to provide inputs in response to the request from the Board (EB 75 report, paragraph 43), as contained in annex 1 to this report.
- 13. The A/R WG recommended that the Board <u>take note</u> that the A/R WG welcomed the initiative by the Board to identify areas of future strategic methodological developments

and to make best use of the methodology-related panels and working groups within the context of the potential new role of the CDM in monitoring, reporting and verification under results-based financing. The members of the AR/WG expressed their interest in contributing to the process.

14. The members also acknowledged the usefulness of electronic meetings in conducting the business of the panels and working groups, while noting that the A/R WG is the first of the panels and working groups of the Board to have conducted a meeting through electronic means.
