We intend to do it through three main measures: Developing a web-app that improves communication and data-sharing in the auditing process, Providing alternative verification evidences, Registering all information used in a blockchain platform

o do so, we propose to replace on site inspection by using a blockchain platform where the following evidences will be uploaded so the auditor can verify the implementation of the project activity and the monitoring practices: SATELLITE IMAGES to be able to check the number of wind turbines and their location, EMISSION REDUCTION CALCULATION SPREADSHEET, VIDEOCONFERENCE INTERVIEWS with facility workers, to record and make them available, DATED VIDEO CONFERENCE CALL to place both meters and grid interconnection point and assure they are
