- 2. The CDM-AP noted that Ms. Verónica Garcia de Solorzano was unable to attend the meeting. She provided proper justification for her absence.
- 3. The CDM-AP noted that Mr. Amjad Abdulla was unable to attend the second day of the meeting.

- 6. The CDM-AP considered information provided by members, the Chair and the Vice-Chair with respect to any potential conflict of interest.

Agenda item 2. Governance and management matters

Agenda item 2.1. Performance management

- 7. The CDM-AP took note of a report on the achievements made against the 2019 assessment plan and on the assessment plan for 2020.
- 8. The CDM-AP took note of information provided for the purpose of designated operational entity (DOE) performance monitoring.
- 9. The CDM-AP took note of a report on delays of more than seven days in ongoing assessments.
- 10. The CDM-AP considered the outcome of the performance monitoring of experts on the CDM accreditation roster of experts (ARoE) and agreed on appropriate actions.

11. The CDM-AP considered the annual impartiality analysis prepared in accordance with paragraphs 15 and 16 of the "Procedure: Selection and performance evaluation of experts on the CDM accreditation roster of experts" and had no further input on the mitigation actions presented by the secretariat.

- 12. The CDM-AP considered whether to launch a call for experts to serve on the CDM ARoE and agreed that in view of fewer submissions and assessments being carried out, the resources on the roster are sufficient to cover current levels of activities. Accordingly, the CDM-AP recommended to the Board that at present there is no need to launch a call for experts to serve on the roster.
- 13. The CDM-AP took note of information pertaining to the form "Work plan for the CDM Assessment Team" (CDM-WP-FORM).

Agenda item 2.2. Matters related to the panel

- 14. The CDM-AP took note of the outcomes of the 105th meeting of the Board that are relevant to the work of the CDM-AP.
- 15. The CDM-AP took note of the tentative schedule of CDM-AP meetings for 2020.

Agenda item 3. Rulings (case-specific matters)

- 16. The CDM-AP considered one re-accreditation case. The CDM-AP's recommendation on this case will be submitted to the Board in confidence.
- 17. The CDM-AP considered three regular surveillance cases. The CDM-AP's notifications on these cases will be submitted to the Board in confidence.
- 18. The CDM-AP considered four performance assessments. The CDM-AP's notifications on these cases will be submitted to the Board in confidence.
- 19. The CDM-AP considered 13 notifications of change.

- 20. The CDM-AP provided input on the revised "Procedure: Performance monitoring of designated operational entities". The work was carried out in response to the mandate from the Board at its 105th meeting to revise the procedure in consultation with the CDM-AP, for consideration by the Board at its next meeting.
- 21. The CDM-AP provided input on the proposed amendments to the "CDM accreditation procedure". The work was carried out as the temporary modification regarding the frequency of performance assessments was due to expire 28 May 2020 and to align the procedure with the amendments proposed to the "Procedure: Performance monitoring of designated operational entities".
