A period of 3 months for the renewal of the credit period of the CDM MIO project, CALI COLOMBIA with UNFCCC registration No. 5852. We respectfully consider that this period is very short for such a great administrative, contractual, environmental and social commitment to the city and its interest groups; and for this reason we are obliged to request again the possibility of having a term of 12 months for the effective achievement of the credit renewal and all that this implies for the sustainability of the CDM project be studied.</p> <p>MIO (Massive Integrado de Occidente) seeks to optimize the city's transport system, increasing the level of well-being of the urban community, reducing the environmental externality from the transport sector, contributing to economic development, social welfare and environmental</p>

The search for a balance between these objectives directs the project towards the sustainable development of Cali and guarantees the improvement of the quality of life of the urban population. For this reason, the MIO, more than a transportation project, is a project of urban environmental reorganization and sustainability. In addition, we have been affected by the pandemic due to the confinement of people, social distancing and fear of contagion. Generating a great negative impact on the SITM-MIO in terms of great limitation of attention to demand and consequently, in terms of income received via tariffs and financial unsustainability.</p> <p>However, Metro Cali S.A. continues to develop multiple strategies to promote the strengthening of the SITM-MIO, seeking to improve its financial conditions in the medium term (during and after the emergency period caused by the spread of the virus), including the purchase of the acquisition of more electric vehicles and / or low emissions. It is worth mentioning that, for example, Metrocali at the end of 2019 puts at the service of the city a fleet of 26 electric buses that are characterized by being environmentally sustainable, with zero gas and noise emissions. This effort implies a reduction in emissions of 188,366 Ton CO2.</p> <p>In consideration of the foregoing, we reaffirm our intention to please have the 12 months required for the successful achievement of the project's credit renewal.</p>
