Like other practitioners of the CDM, in December/2019 we were very thankful with the decision of the CDM Executive Board (CDM-EB) on its 105th meeting (EB 105) of extending to 30/09/2020 the previously agreed 31/12/2019 deadline for the submission of requests of renewal of crediting period for project activities (PAs) and component project activities (CPAs) (of which crediting period has expired prior or on 30/09/2019 (i.e. "overdue cases").</p> |   |  |

The uncertainty of post 2020 CDM future has also resulted in some extra difficulty for PPs to renew the crediting periods.</p> <p>In light of all these circumstances, we would like to suggest to the Board to consider having the currently valid and above referred deadline being extended for the above mentioned project. A decision in this direction would definitely contribute for the successful continuation of different PAs / CPAs (from which project participants and Coordinating Managing Entities (CMEs) and related CDM consultants/advisors are struggling on meeting a deadline that unfortunately seems not to be achievable due to a pandemic that is sadly affecting all of us worldwide).</p> |
