<b>Communication Text</b> Include background, details, and conclusion (unlimited length)	<ul> <li>Dear Sir/Madam,</li> <li>Enel Green Power [*] (Enel), as responsible for Project number 9064 (Cristal, Primavera and São Judas Wind Farms), hereby requires the extension of the deadline for submission of request for renewal of crediting period, as follows:</li> <li>Project number 9064 (Cristal, Primavera and São Judas Wind Farms) was registered in 2012 along with 5 other Enel's wind farms projects. The 6 year-period of the first period of credit ended on 31 August 2020 and Enel decided to apply for renewal of crediting period, which should be made until 31 August 2021 (item 278 of Procedure: CDM project cycle procedure for project activities).</li> <li>However, Enel respectfully informs the Board that, in the context of the COVID-19 pandemic, it is facing obstacles and it will not be able to submit the request for renewal of crediting period until 31 August 2021. In fact, due to the COVID-19 pandemic, that severely affects Brazil, Enel confronted:</li> </ul>

	lockdowns, limited access to the offices and travels to site, restricted availability from DOEs to perform validation assessments in the Project's region, and budged constraints. Indeed, the pandemic scenario justified the Board acts that, "on an exceptional basis, considering the COVID-19 pandemic": (i) relaxed the mandatory on-site inspections until 31 December 2020 (link); and (ii) extended the deadline for submission of requests for renewal of crediting periods for overdue other projects (107th and 108th meeting). Considering the above, Enel dutifully requires the extension of the deadline for submission of request for renewal of crediting period for Project number 9064 (Cristal, Primavera and São Judas Wind Farms) to 30 January 2022.
