



**Validation and verification by same DOE authorization request form
(Version 04.0)**

This form is to be used by the DOE to submit a request for authorization from the Board (i) to perform verification for a project activity or programme of activities (PoA) if the DOE has performed a validation activity for the same project activity or PoA; or (ii) to perform validation for renewal of crediting period of a project activity or CPA, or renewal of PoA period, if the DOE has performed verification for the same project activity or PoA.
