Established in January 2013

UN Climate Change (UNFCCC)

With 197 Parties, the United Nations Framework Convention on Climate Change (UNFCCC) was adopted in 1992 and has near universal membership.

UNFCCC provides support to the negotiations and climate change regime, promotes stakeholder engagement and mobilization and provides operation management support.

West African development bank (BOAD)

Created on November 14, 1973. The purpose of the bank is to promote equitable development of Member states by mobilising resources and contribute to the achievement of economic integration in West Africa. The Bank has developed Climate and Environment strategy and is also a member to the Mainstreaming climate action in financial institution

Background

RCCs were established to spread the benefits of the Clean Development Mechanism (CDM). Since the adoption of the Paris Climate Change Agreement in December 2015, the RCCs have had the broader task of supporting implementation of countries' Nationally Determined Contributions under the agreement.
