1. Introduction

- 1. The Executive Board of the clean development mechanism (CDM) (hereinafter referred to as the Board), through the CDM Executive Board workplan 2023,¹ requested regular reports on progress made in specific areas.
- 2. This report covers the regional support provided by Regional Collaboration Centres (RCCs) for the development and implementation of CDM project activities and Programmes of Activities (PoAs) and the development of standardized baselines in the respective regions. The report also includes information on the promotion of the CDM, capacity-building and inter-agency partnerships of the RCCs. The first RCC was established in Lomé, Togo, in 2013, followed by RCCs in Kampala, Uganda; St. George's, Grenada; Bogotá, Colombia; Bangkok, Thailand; and Dubai, United Arab Emirates. RCC Bogotá, which has been in operation since August 2013, was moved to Panama City, Panama, in March 2017. These RCCs focus on supporting the implementation of the CDM in their regions.
- 3. In 2023, the names of the RCCs have been rebranded as follows in order to clearly communicate to stakeholders the regional coverage of each RCC:
 - (a) RCC Asia and the Pacific (Bangkok, Thailand);²
 - (b) RCC Caribbean (St. George's, Grenada);³
 - (c) RCC East and Southern Africa (Kampala, Uganda);⁴
 - (d) RCC Latin America (Panama City, Panama);⁵
 - (e) RCC MENA and South Asia (Dubai, United Arab Emirates);⁶ and
 - (f) RCC West and Central Africa (Lomé, Togo).⁷
- 4. The current reporting period covers 1 January to 31 December 2023. Cumulative figures covering the beginning of RCC operations in 2013 until 31 December 2023 are also presented in this report to reflect the support provided for the development and implementation of CDM project activities and PoAs and the development of standardized baselines.⁸

2. Regional support

2.1. Support for project activities and programmes of activities

- 5. From 1 January to 31 December 2023, the RCCs provided direct technical support to eight CDM project activities and PoAs, of which two are in Latin America, five are in East and Southern Africa and one is in West and Central Africa. In addition, RCCs responded to 43 queries received from stakeholders (7 from Latin America, 18 from East and Southern Africa, 15 from West and Central Africa and 3 from Middle East and Northern Africa (MENA) and South Asia), which were primarily related to: (i) requests for clarification of consideration CDM rules (e.g. prior of the CDM. applicability of methodologies/standardized baselines/tools, post-registration changes); (ii) renewal of crediting period; and (iii) temporary measures agreed by the Board at its 108th meeting (EB 108). The RCCs also responded to 50 gueries relevant to the transition of CDM project activities and PoAs under the mechanism established by Article 6, paragraph 4, of the Paris Agreement (Article 6.4 mechanism).
- 6. From the beginning of their operations until 31 December 2023, the RCCs provided direct support to 1,742 CDM project activities and PoAs, contributing to 259 CDM project activities and PoAs progressing at least one step forward in the CDM project cycle. In addition, through the provision of technical advice and capacity-building, 128 new CDM project activities and PoAs were identified and their notification of CDM prior consideration submitted.

2.2. Support in the development of standardized baselines

- 7. In 2023 RCCs supported seven countries in the development of bottom-up standardized baselines, including two countries from Asia and the Pacific, three from East and Southern Africa, and two from West and Central Africa. The majority of the interactions were about procedures for the renewal of expired or about-to-expire standardized baselines.
- 8. From the beginning of the RCCs' operations in 2013 until 31 December 2023, the RCCs directly supported the development of 366 standardized baselines, of which 58 were approved by the Board.

2.3. Promotion of the clean development mechanism and other climate actions and capacity-building

- 9. The RCCs supported CDM stakeholders under goal 2 of the CDM two-year business and management plan 2022–2023⁹ ("Enable stakeholders to understand and adjust to the evolving operating environment taking into account decisions of the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol at its sixteenth session), specifically for objectives 2(a) ("Engage with regulatory authorities using certified emission reductions for compliance purposes") and 2(b) ("Engage with stakeholders using certified emission reductions for voluntary purposes").

- 11. In this reporting period, the RCCs published 109 global and regional newsletters on their individual websites: 27 for the Africa region; 19 for the Asia-Pacific region; 33 for the Latin America and the Caribbean region; 15 for the MENA and South Asia region; and 15 global newsletters and campaigns. These newsletters provide technical advice, inform readers on relevant events, facilitate cooperation and promote opportunities for project funding. The newsletters have received positive feedback from the CDM stakeholders.
- 12. The annual RCC Global Forum for 2023 will take place in the first half of 2024 to take stock of 2023 achievements in the context of the new 2024–2025 RCC workplan.
- 13. The RCCs supported the organization of a regional DNA Forum for each region on the margin of the Regional Climate Weeks 2023.¹⁰ A total of 73 DNA representatives attended the meetings to exchange views and share their experiences relating to the CDM.

2.4. Inter-agency partnerships

- 14. The RCCs forged and maintained collaborations for the implementation of their workplan, including the delivery of the events listed in paragraph 10 above, with a wide variety of entities. These include but are not limited to:

- 15. In this reporting period, a total of 30 RCC technical experts and administrative support staff worked together with the 6 United Nations Framework Convention on Climate Change regional leads. Technical experts and administrative support staff were mobilized through various sources, including the RCC host partners, internships, and the United Nations Junior Professional Officer and volunteers' programmes.
