1. Introduction

- 1. The Executive Board of the clean development mechanism (CDM) (hereinafter referred to as the Board), through the CDM Executive Board workplan 2024,¹ requested regular reports on progress made in specific areas.
- 2. The six Regional Collaboration Centres (RCCs) provide support for the development and implementation of CDM project activities and Programmes of Activities (PoAs) and the development of standardized baselines in the respective regions:
 - (a) RCC Asia and the Pacific (Bangkok, Thailand);²
 - (b) RCC Caribbean (St. George's, Grenada);³
 - (c) RCC East and Southern Africa (Kampala, Uganda);⁴
 - (d) RCC Latin America (Panama City, Panama);⁵
 - (e) RCC MENA and South Asia (Dubai, United Arab Emirates);⁶ and
 - (f) RCC West and Central Africa (Lomé, Togo).⁷
- 3. This report includes information on the capacity-building activities organized by the RCCs and the collaborations undertaken with other organizations in the period from 1 January to 31 December 2024. Cumulative figures covering the beginning of RCC operations in 2013 all the way through to 31 December 2024 are presented in this report to reflect the support provided for the development and implementation of CDM project activities and PoAs and the development of standardized baselines.⁸

2. Regional support

2.1. Support for project activities and programmes of activities

4. From 1 January to 31 December 2024, the RCCs provided direct technical support to project developers of twenty-five CDM project activities and PoAs (3 from Asia-Pacific, 8 from East and Southern Africa, 3 from Latin America, 8 from Middle East and North Africa and 3 from West and Central Africa) with issues related to the CDM requirements and transition to Article 6.4 mechanism. In addition, RCCs responded to 25 queries from other stakeholders (4 from Asia-Pacific, 7 from East and Southern Africa, 5 from Latin America, 5 from Middle East and North Africa and 4 from West and Central Africa), which were primarily related to on CDM transitioning and other generic methodological matters.

5. From the beginning of their operations until 31 December 2024, the RCCs provided direct support to 1,778 CDM project activities and PoAs, contributing to 259 CDM project activities and PoAs progressing at least one step forward in the CDM project cycle. In addition, through the provision of technical advice and capacity-building, 128 new CDM project activities and PoAs were identified and their notification of CDM prior consideration submitted.

2.2. Support in the development of standardized baselines

- 6. In 2024 RCCs supported one country (Honduras) by clarifying procedural matters related to the update of the grid emission factor of the electricity system of Honduras and its approval as a standardize baseline under the Paris Agreement Crediting Mechanism.
- 7. From the beginning of the RCCs' operations in 2013 until 31 December 2024, the RCCs directly supported the development of 366 standardized baselines, of which 58 were approved by the Board.

2.3. Promotion of the clean development mechanism and other climate actions and capacity-building

- 8. The RCCs supported CDM stakeholders under goal 2 of the CDM two-year business and management plan 2024–2025⁹. To this aim, the RCCs organized, co-organized or participated in 90 events on carbon markets, during which they addressed stakeholders' queries about requirements for transitioning CDM project activities and PoAs to the Article 6.4 mechanism and promoted the CDM as a tool for voluntary climate action. - 9. During the reporting period, the RCCs published 52 global and regional newsletters on their individual websites: 12 for the Africa region; 8 for the Asia-Pacific region; 15 for the Latin America and the Caribbean region; 8 for the MENA and South Asia region; and 9 global newsletters and campaigns. These newsletters provide technical advice, inform readers about relevant events, facilitate cooperation, and promote opportunities for project funding. They have received positive feedback from CDM stakeholders.
- 10. The annual RCC Global Forum for 2024 took place on 11 November 2024 on the margins of COP 29. Over 30 participants from RCC hosting partners, development organizations, key partners and UNFCCC senior management shared information, experiences, and perspectives on the work of the RCCs.

- 12. In this reporting period, a total of 30 RCC technical experts and administrative support staff worked together with the 6 United Nations Framework Convention on Climate Change regional leads. Technical experts and administrative support staff were mobilized through various sources, including the RCC host partners, internships, and the United Nations Junior Professional Officer and volunteers' programmes. The staffing situation at each RCC is as follows:
 - (i) RCC East and Southern Africa: 6;
 - (ii) RCC West and Central Africa: 6;
 - (iii) RCC Asia and the Pacific: 6;
 - (iv) RCC Latin America: 6;
 - (v) RCC Caribbean: 5;
