- 4. The CDM-AP considered information provided by members, the Chair and the Vice-Chair, with respect to any potential conflict of interest.

- 5. The CDM-AP took note of the report on the achievement against the 2025 assessment plan.
- 6. The CDM-AP took note of two delays of more than seven days in on-going assessments of two designated operational entities (DOEs) and made a recommendation to the Executive Board of the CDM (hereinafter referred to as the Board).
- 7. The CDM-AP took note of DOE performance monitoring reports to the Board and the CDM-AP on twenty-sixth monitoring report (second iteration), twenty-seventh monitoring period (second iteration) and twenty-eighth monitoring period (first iteration, which is also the final version), in accordance with the "Procedure: Performance monitoring of designated operational entities" (ver. 05.0) and made a recommendation to the Board.
