## **Profiles of the Presenters**

#### 1. Mr. Alberto Galante, Perspectives GmbH

**Mr. Galante** studied Industrial Engineering with a major in Power Generation at the Comillas Pontifical University - ICAI of Madrid, Spain. Before joining Perspectives, he worked for the Spanish environmental consulting firm Garrigues Medio Ambiente for several years as a Consultant specialized in Climate Change & Renewable Energy. There, he was part of an international climate change network and was involved in over 30 CDM related projects in more than 10 different countries, mainly in Latin America. He has actively worked with clients of the public and private sector in areas such as CDM project design, carbon finance due diligence, cost-benefit analysis of emission reduction policies, carbon offsetting, technical appraisal of EUA allocation and GHG emissions inventories for industries, among others.

At Perspectives GmbH, the work focus of Alberto Galante lies in CDM/PoA development and risk assessment especially in the areas of energy efficiency, renewable energy and landfill gas. Furthermore, he is also experienced in conducting CDM capacity building workshops including Programme of Activities (PoAs).

#### 2. Mr. Bill Farmer, Uganda Carbon Bureau

#### 3. Ms Carolyn S. Neufeld, KfW Carbon Fund

**Ms Neufeld** is an economist by profession and has been working at KfW for seven years in various functions. She looks back on eight years of experience in international cooperation with developing countries with a focus on programmes in the agrarian and environmental sector and on microfinance. Before co-founding South Pole he was a consultant and carbon finance expert with McKinsey & Company. #### 5. Ms Felicity Spors, World Bank

**Ms Spors** has been working in the field of climate change since 1999. She is a trained Environmental Auditor and holds an MSc in Environmental Technology from Imperial College London. Her interest in GHG mitigation projects started with her Research on Solar

Thermal Technologies in Israel, funded through an IEA scholarship.
